(Excluding State Government holidays)
4. The tenders shall be accepted in the office of the undersigned from 3<sup>rd</sup> May 2006 to 17<sup>th</sup> May 2006 during 11.00 a.m. to 4.00 p.m. (excluding State Government holidays)
5. The tenderer will have to deposit earnest money of Rs.1,00,000/- in the form of Bank Demand Draft payable to Under Secretary, General Administration Department.

Please note that only firms having a turnover of at least Rs.1.00 Crore per annum for financial years 2003-2004 and 2004-2005 in printing/IT business should quote for the tender in Indian Currency either directly or a single channel partner. The firms should be willing to carry out the actual printing work within the State of Maharashtra only.
7. Please note that it is essential for the bidders to have the requisite experience in printing work of electoral rolls or similar type of work, which involves sorting and binding of printed matter.
8. The Technical tenders will be opened on 17<sup>th</sup> May 2006 at 4.30 P.M. and The Price tenders will be opened on 20<sup>th</sup> May 2006 at 4.00 P.M in the office of the undersigned. The tenderer or their representatives may remain present if they so desire.
