Note No. 5 Significant Accounting Policies and other explanatory information forming part of Financial Statements for the year ended on 31.03.2019.

(a) Basis of Preparation

The Financial Statements of the Organization have been prepared on an accrual basis and under the historical cost convention. The Financial Statements of the organization have been prepared in accordance with generally accepted accounting principles in India. The Organization has prepared these Financial Statements to comply in all material respects, with the Accounting Standards. The accounting policies adopted in the preparation of financial statements are consistent with those of previous year except for the change in the accounting policy, if any explained below.

(b) Change in Accounting Policy

The accounting policies have been consistently applied by the Organization. The Organization has reclassified the previous figures in accordance with the requirements applicable in the current year.

(c) Revenue Recognition

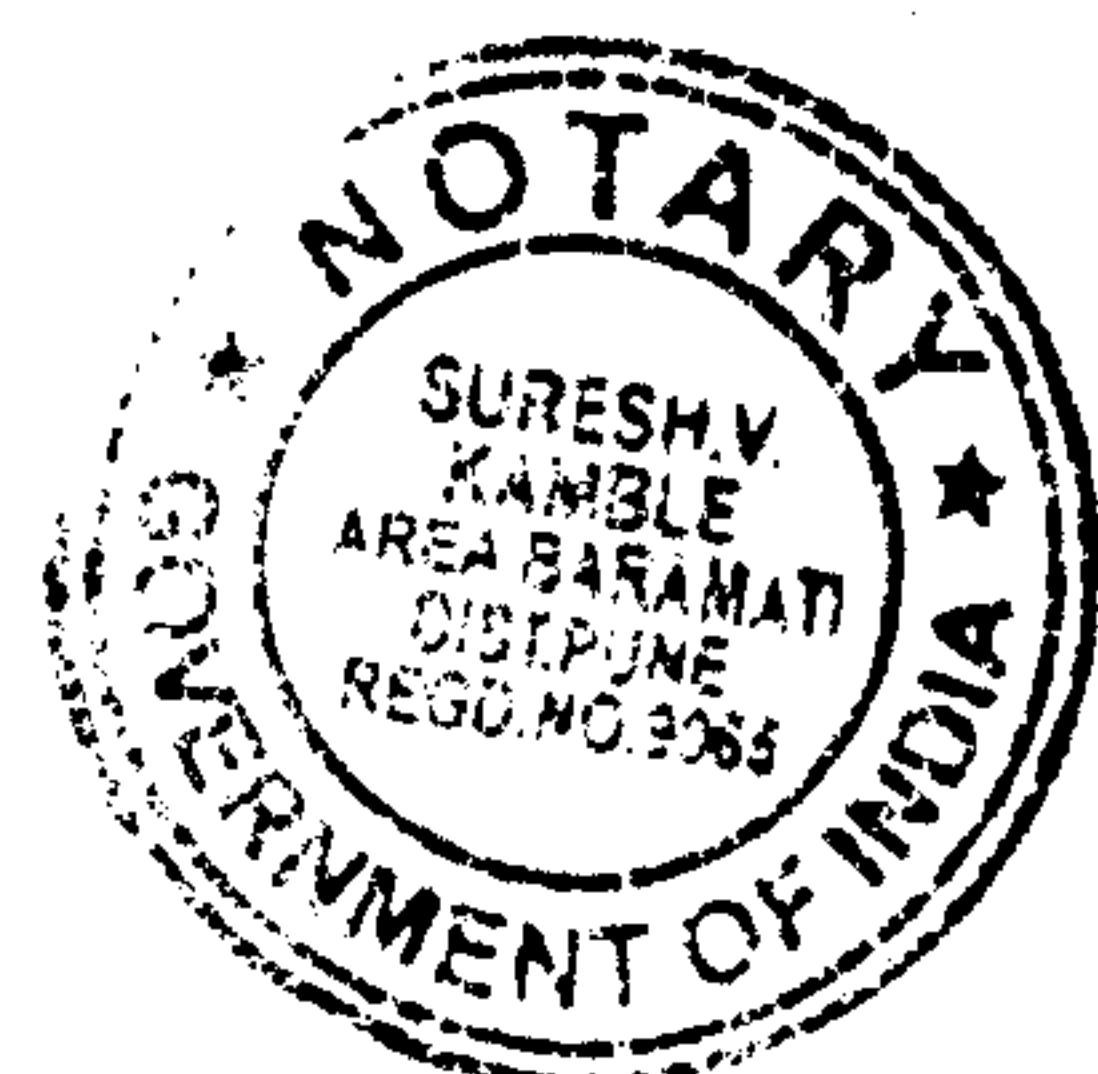
Revenue is recognized to the extent that it is probable that the economic benefits will flow to the organization and the revenue can be reliably measured. Revenue from services is accounted for on time proportion basis.

(d) Fixed Assets

Fixed assets are shown at cost less accumulated depreciation and impairment losses, if any. The cost comprises of the purchase price and the cost directly attributable to bring asset to its working condition for its intended use. Subsequent expenditure related to an item fixed asset is added to its book value only it increases the future benefits from existing assets beyond its previously assessed standard performance. All other expenses on existing fixed assets, including day-to-day repair and maintenance expenditure are charged to the statement of profit and loss for the period during which such expenses are incurred. However there is no fixed asset during the year under audit.

(e) Intangible Assets

Intangible assets acquired separately are measured on initial recognition at cost. Intangible assets are carried at cost less accumulated amortization and accumulated impairment losses, if any. Subsequent expenditure related to an item of fixed asset is added to its book value only if it increases the future benefits from the existing asset beyond its previously assessed standard of performance. All other expenses on existing fixed assets, including day-to-day repair and maintenance expenditure are charged to the statement of profit and loss for the period during which such expenses are incurred.

(f) **Depreciation and amortization**

Depreciation on fixed assets is calculated on straight line basis using the rates arrived at, based on the useful lives estimated by the management. Depreciation is provided from the month of acquisition of fixed assets. However there are no fixed assets as well as depreciable assets hence during the year no depreciation has been charged.

(g) **Investments**

Investments are stated at Cost however there no investment during the year under audit.

(h) **Provisions**


A provision is recognized when the organization has present obligations as a result of past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligations and reliable estimate can be made of amount of the obligation. Provisions are not discounted at their present value and are determined based on the best estimate required to settle the obligation at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.


(i) **Contingent Liabilities**

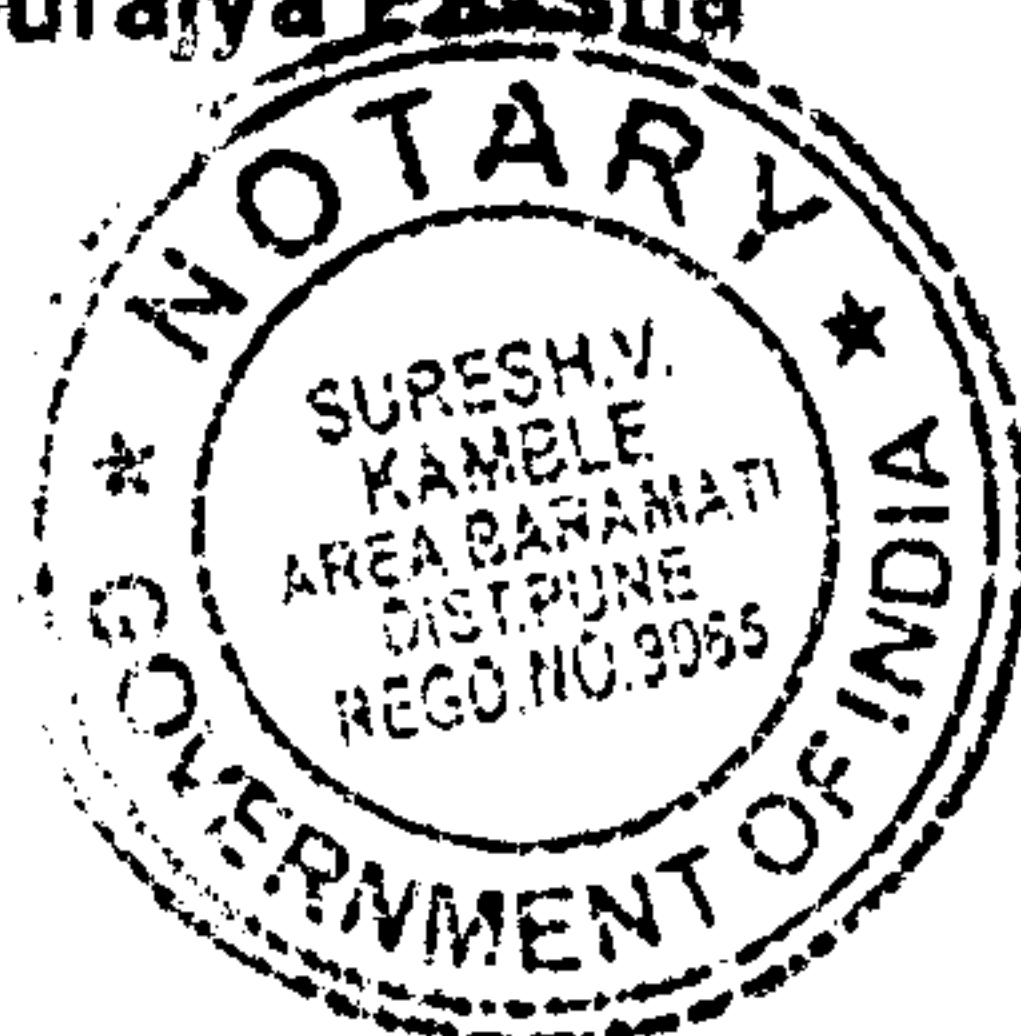

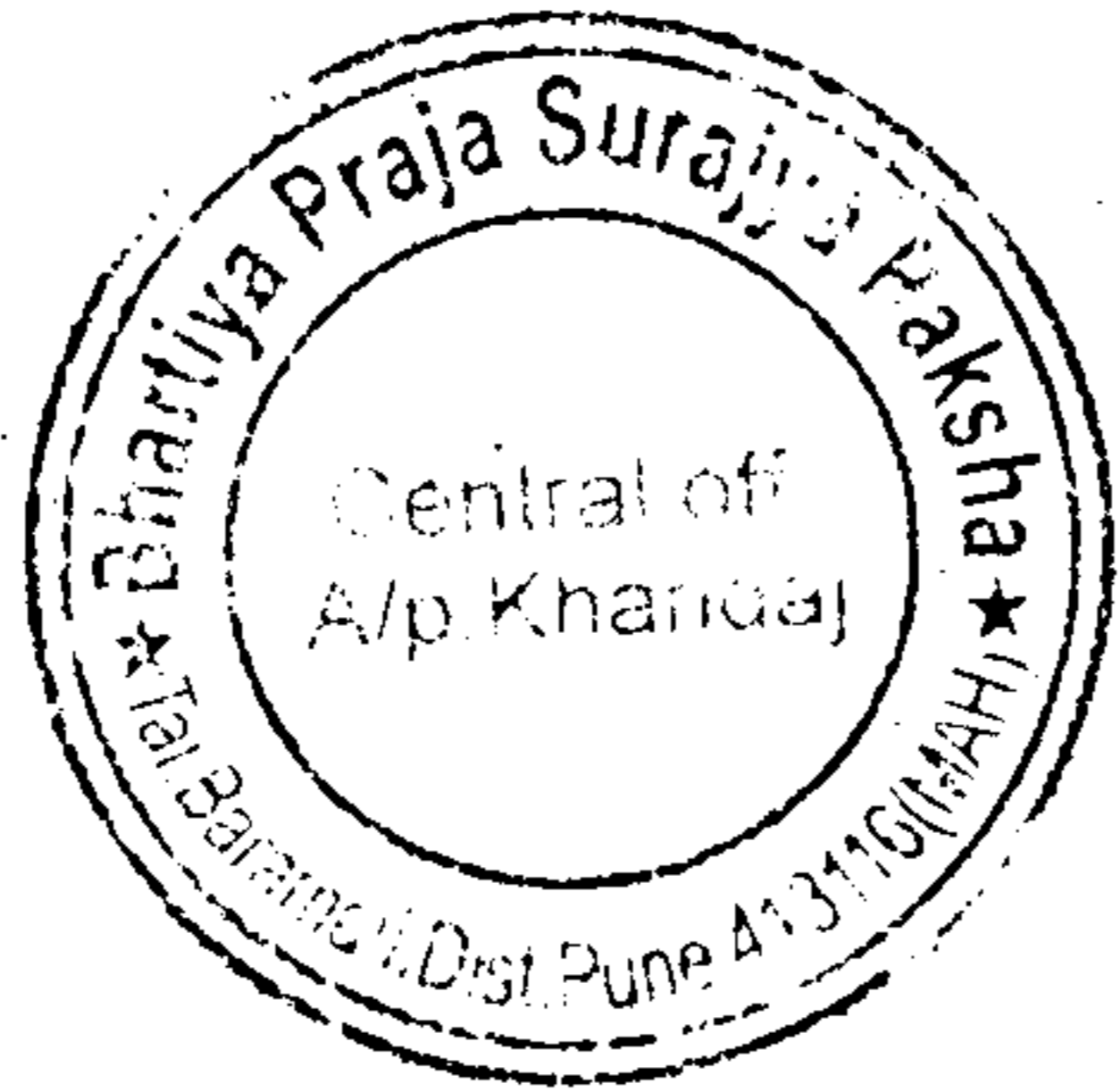

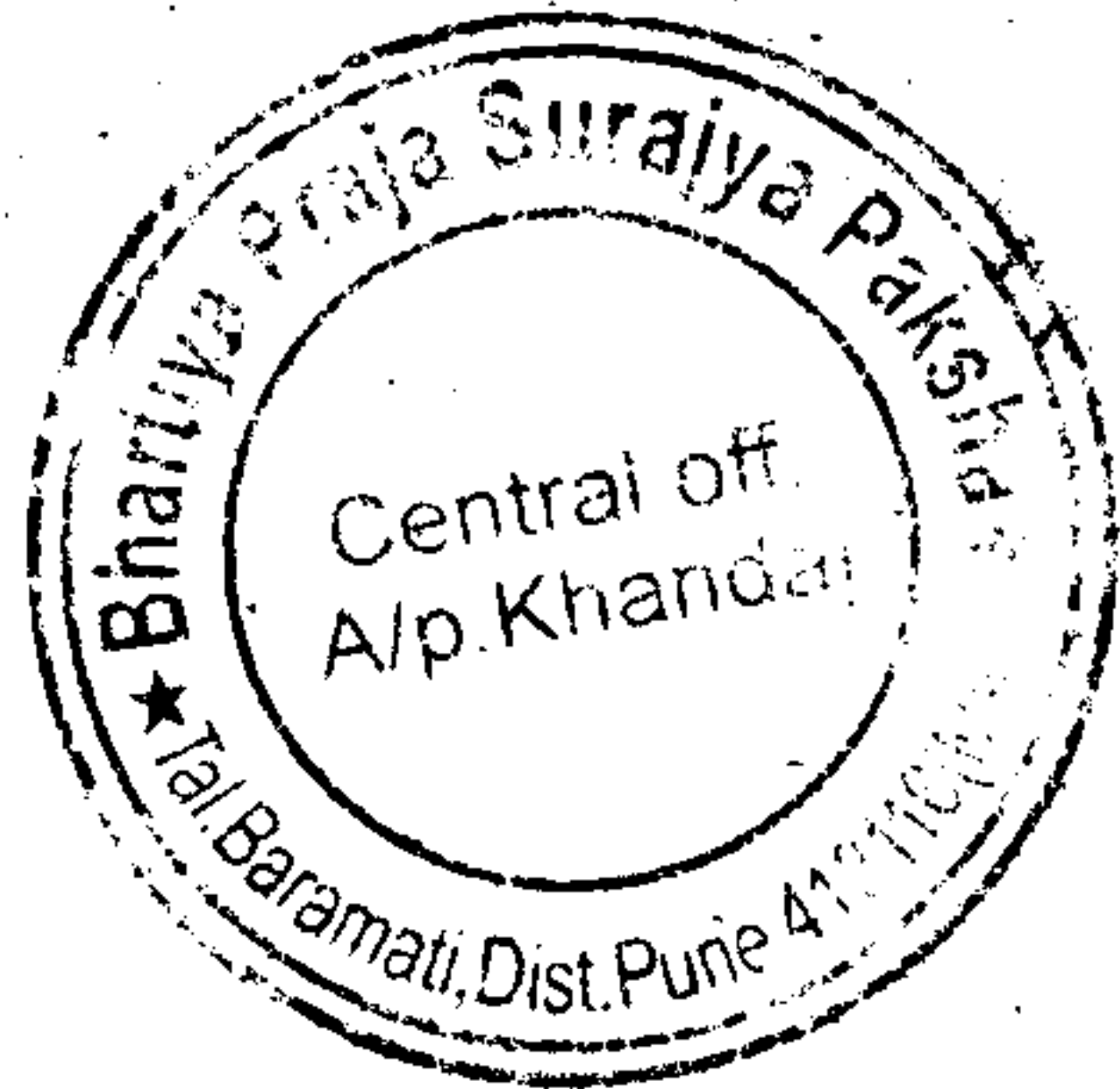
