**14. Name and address of Representative Assessee**

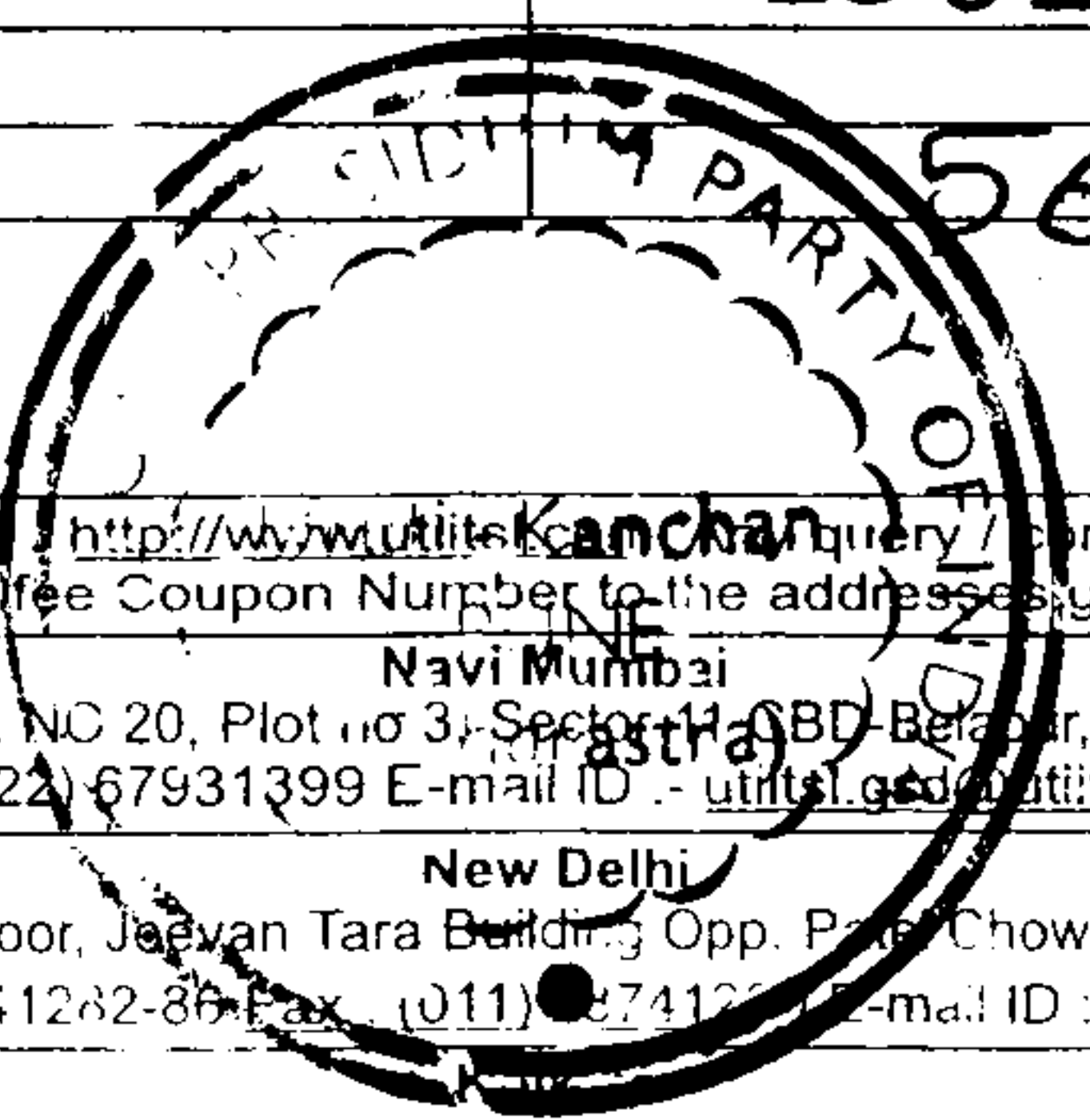

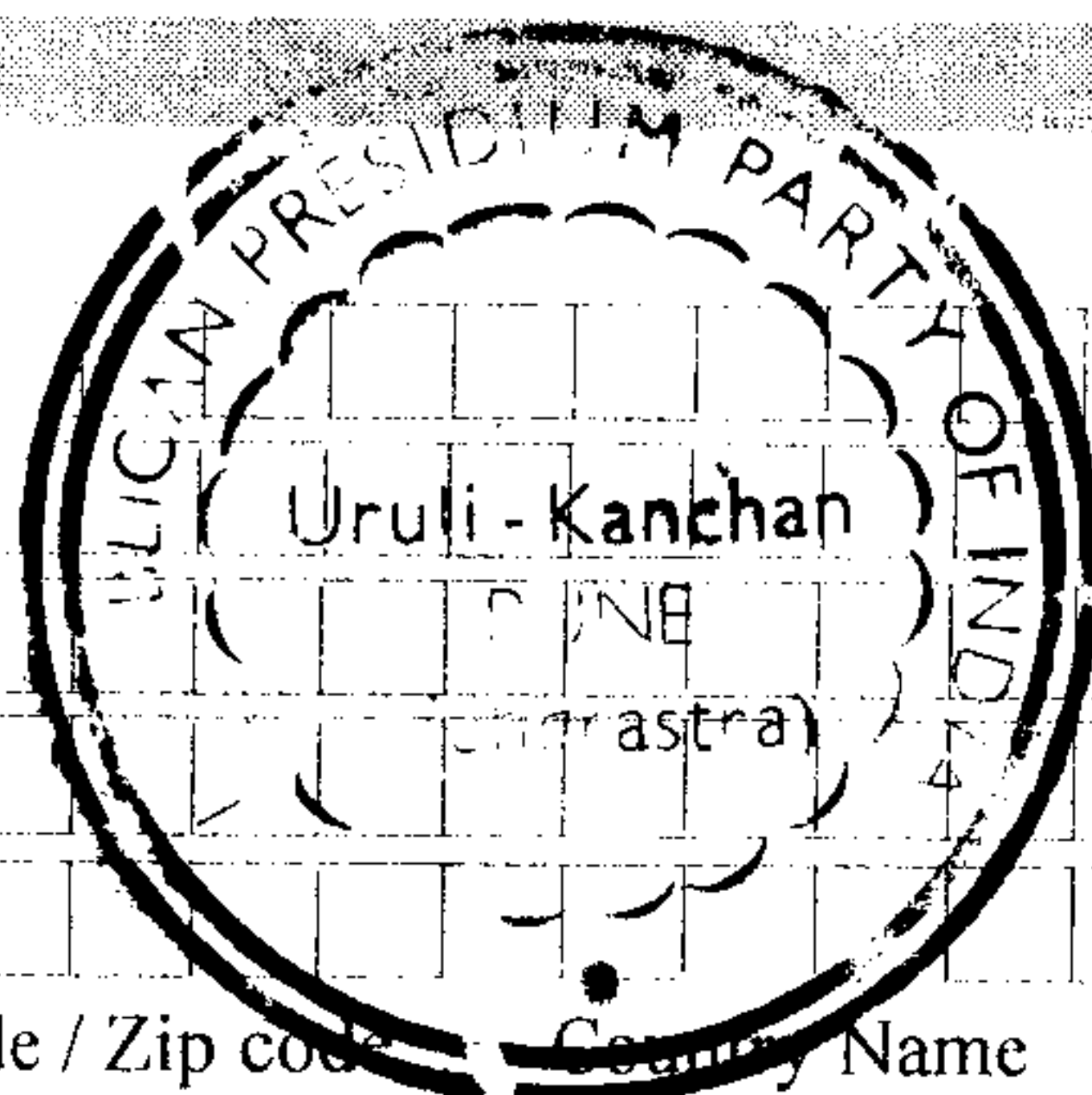

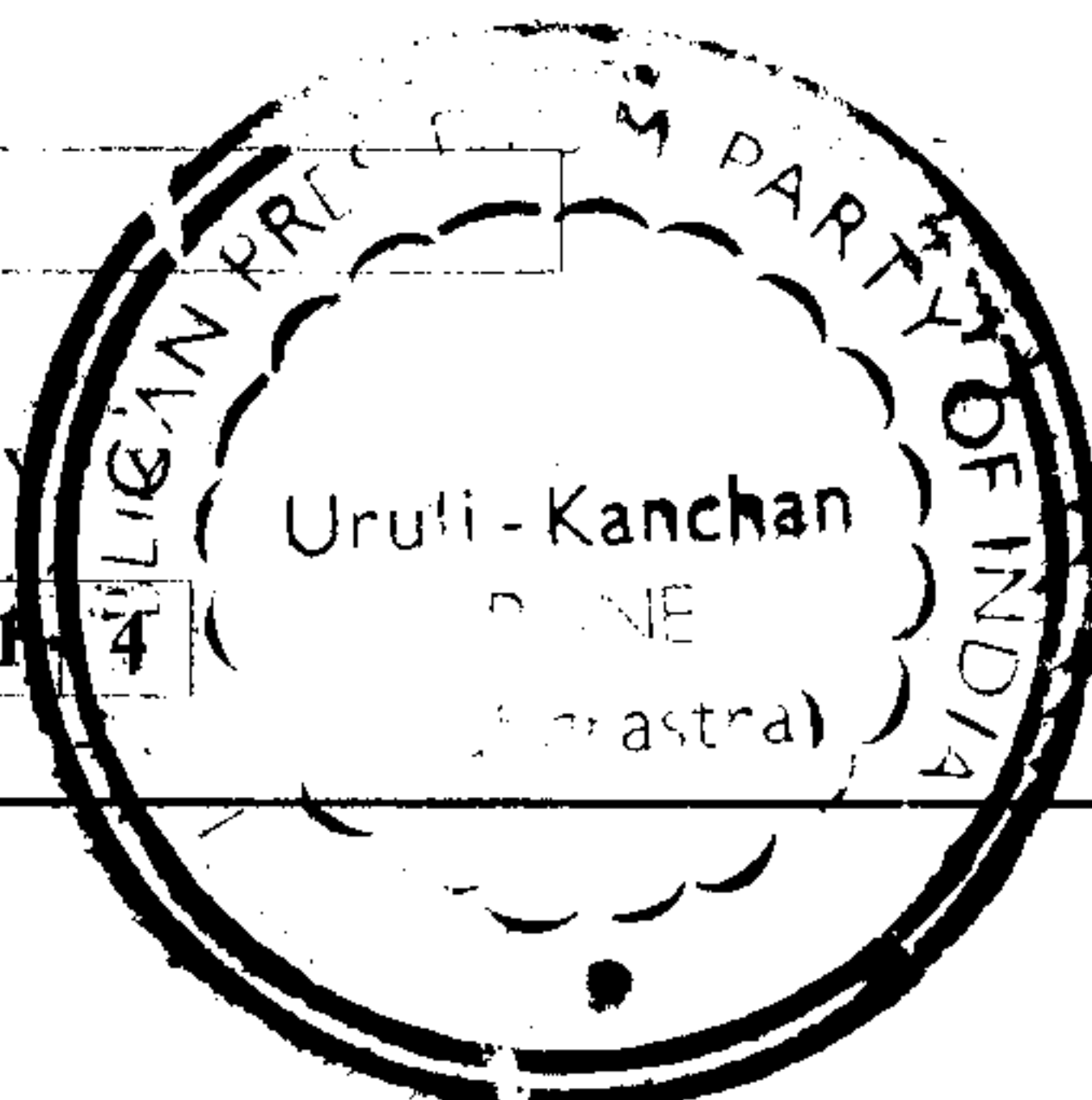
