NOTIFICATION

No. 464/MT-LA/2014.—Whereas, the Governor of the State of Maharashtra has, by notification issued under sub-section (2) of section 15 of the Representation of the People Act, 1951 (43 of 1951) and published in the *Official Gazette* of the State on 20th September 2014, been pleased to call upon all Assembly Constituencies in the State, to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder;

Now, therefore, in pursuance of sections 30 and 56 of the said Act, the Election Commission of India hereby—

(A) Appoints, with respect to the said election in each of the constituencies,—

(a) the 27th September 2014 (Saturday), as the last date for making nominations ;

(१)

- (b) the 29th September 2014 (Monday), as the date for the scrutiny of nominations ;
- (c) the 1st October 2014 (Wednesday), as the last date for the withdrawal of candidatures ;
- (d) the 15th October 2014 (Wednesday), as the date on which a poll shall, if necessary, be taken ; and
- (e) the 22nd October 2014 (Wednesday), as the date before which the election shall be completed ; and

(B) Fixes the hours from 7-00 a.m. to 6-00 p.m., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election in all the Assembly Constituencies except 66-Amgaon (ST), 67-Armori (ST), 68-Gadchiroli (ST) and 69-Aheri (ST) Assembly Constituencies where it shall be from 7-00 a.m. to 3-00 p.m.
